11	pursuant to RSA 541-A for <i>applications for conditional licensure and</i> supervisory agreements;
12	applications for licensed pastoral psychotherapist, independent clinical social worker, school social
13	worker, licensed social worker, licensed social work associate, clinical mental health counselor,
14	marriage and family therapist, and conditional licenses; renewal of license; renewal of dual license;
15	reinstatement of license; inactive license status; reactivation of an inactive license; examination of
16	applicants; transcribing and transferring records; and other services, including investigations and
17	hearings conducted under this chapter.
18	9 Social Work; Conditional License. Amend RSA 330-A:18-d, I to read as follows:
19	I. Applicants for licensure under this section may apply to the board for conditional
20	licensure. To receive a conditional license, applicants shall comply with the following requirements:
21	(a) Clinical Social Worker:
22	(1) Hold a master's or doctoral degree in social work or social welfare from a CSWE
23	approved program.
24	(2) Obtain a board approved supervisory agreement with documented intent to
25	pursue licensure as a clinical social worker under this chapter.
26	(3) Meet other criteria as reasonably established by the board.
27	(4) Upon approval of the supervision agreement, the board shall issue a
28	conditional license.
29	(5) Conditional licensees are subject to the jurisdiction of the board.
30	(b) School Social Worker:
31	(1) Hold a master's or doctoral degree in social work or social welfare from a CSWE

21	granting program or separately.
22	(3) Complete 300 hours of supervised practical training within the degree-granting
23	program, as part of the supervised work experience or separately.
24	(4) Obtain a board approved supervisory agreement consistent with RSA 330-A:18-c,
25	III, with documented intent to pursue licensure as a licensed social work associate under this
26	chapter.
27	(5) Meet other criteria as reasonably established by the board.
28	(6) Upon approval of the supervision agreement, the board shall issue a
29	conditional license.

27	A:21 by inserting after paragraph III the following new paragraphs:

30	(a) Hold a master's or doctoral degree in family therapy from a program accredited by
31	the Commission on Accreditation for Marriage and Family Therapy Education, or hold a master's
32	degree or doctorate degree with a concentration in the field of marriage and family therapy from a
33	regionally accredited institution, or hold a clinical membership in the American Association for
34	Marriage and Family Therapy.
35	(b) Obtain a board approved supervisory agreement with documented intent to pursue
36	licensure as a marriage and family therapist under this chapter.
