Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Voter Checklist. Amend RSA 654:39 to read as follows: 2 654:39 Verification Every [10] 2 Years. 3 I. In addition to any verification carried out under the provisions of RSA 654:38, the 4 supervisors shall verify the checklist in [1981] 2024 and once every [10] 2 years thereafter in all years ending in an even number. 5 6 II. Between April 1 and August 1 of [1981] 2024 and thereafter in each year ending [with a 7 one in an even number, the supervisors shall post notice of their sessions in 2 appropriate places 8 one of which shall be the town or city's Internet website, if such exists, and published at least twice 9 in a newspaper of general circulation and hold [sufficient] sessions at least once a month for 10 verification of the checklist as in their opinion will enable all eligible voters in said town or ward to 11 appear before them and register or reregister as the case may be. Whenever a person is 12 reregistered, his or her party designation, if any, on the checklist undergoing revision shall not be 13 changed except as provided in RSA 654:34. 14III. Beginning June April 1 of such year, the supervisors shall review the checklist and 15 shall strike therefrom the names of all persons who have not registered or reregistered under 16 paragraphs I and IV; provided, that there shall not be stricken from said checklist the name of any 17 person duly qualified to vote unless such person, not less than 30 days prior to such action, shall 18 have been sent notice by the supervisors at his last known address of his failure to reregister stating 19 the procedure to be followed in order to reregister and have his name retained on said checklist nor 20 unless such person shall have been given a reasonable opportunity to follow said procedure. 21 IV. For the purpose of this section, a person shall be deemed reregistered and need not 22appear before the supervisors if: 23(a) The person voted in any election within the [4] 2 years immediately preceding a [40] 242-year verification; or 25 (b) The person has been added to the checklist since the last state general election. 26 V. Upon completion of verification of the checklist, but in no event later than September 1, 27 the supervisors shall file with the secretary of state the following certificate: We, the supervisors of 28 the checklist (or registrars of voters) of the town (or ward ______) of _____, do hereby 29 certify that we have verified the checklist of registered voters in the town (or ward _____ of the
