#### STATE OF NEW HAMPSHIRE

In the Year of Our Lord Two Thousand Twenty Four

AN ACT establishing a committee to study consent and confidentiality laws applicable to adolescent and young adult health care in New Hampshire.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1	1 Committee Established. There is established a committee to study consent and confidentiality
2	laws applicable to adolescent and young adult health care in New Hampshire.
3	2 Membership and Compensation.
4	I. The members of the committee shall be as follows:
5	(a) Two members of the senate appointed by the president of the senate, including one
6	member from the majority and one member from the minority.
7	(b) Three members of the house of representatives, appointed by the speaker of the
8	house of representatives.
9	II. Members of the committee shall receive mileage at the legislative rate when attending to
10	the duties of the committee.
11	3 Duties. The committee shall:
12	I. Review current New Hampshire health care consent laws, including circumstances where
13	parental consent is not required by law;
14	II. Review New Hampshire confidentiality laws and identify what protections exist for
15	health care information for minors in New Hampshire;
16	III. Solicit testimony from any person or organization with relevant information or
17	expertise; and
18	IV. Assess whether any areas of health care in New Hampshire are not currently covered
19	under existing parental consent laws and do not currently fall under existing New Hampshire or
20	Federal law exemptions to parental consent for medical care.
21	4 Chairperson; Quorum. The members of the study committee shall elect a chairperson from
22	among the members. The first meeting of the committee shall be called by the first-named senate
23	member. The first meeting of the committee shall be held within 30 days of the effective date of this
24	section. Three members of the committee shall constitute a quorum.
25	5 Report. The committee shall report its findings and any recommendations for proposed
26	legislation to the president of the senate, the speaker of the house of representatives, the senate
27	clerk, the house clerk, the governor, and the state library on or before November 1, 2024.

28 6 Effective Date. This act shall take effect upon its passage.

### **METHODOLOGY:**

This bill requires any person or public or private entity to obtain the consent of a parent before performing medical procedures and/or evaluations on, or prescribing medication to, a child. The bill creates a private right of action by allowing parents to bring suit for any violation of the newly-established chapter. While there is no way of knowing how many cases might be brought as a result of the bill, the Judicial Branch has provided the following cost estimates for individual civil cases:

Judicial Branch Average Cost	FY 2024	FY 2025
Superior Court Complex Civil Case	\$1,320.96	\$1,347.38
Superior Court Routine Civil Case	\$493.64	\$503.51

There may also be an indeterminable cost for any state or local government entity that serves as a defendant in the civil suits permitted by the bill.
