AN ACT relative to eligibility for free school meals.

AN ACT relative to eligibility for free school meals.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Schools; Food and Nutrition Programs; School Lunch Eligibility. Amend RSA 189:11-a, I to 2 read as follows:

3 I. Each school board shall make at least one meal available during school hours to every 4pupil under its jurisdiction. Such meals shall be served without cost to any child whose annual household income is less than or equal to 300 percent of the federal poverty guidelines as $\mathbf{5}$ updated annually in the Federal Register by the United States Department of Health and 6 7Human Services under 42 U.S.C. section 9902(2), or at a reduced cost to any child who meets 8 federal income eligibility guidelines. The state board of education shall ensure compliance with this 9 section and shall establish minimum nutritional standards for such meals as well as income 10guidelines set for the family size used in determining eligibility for free and reduced price meals. 11 Nothing in this section shall prohibit the operation of both a breakfast and lunch program in the 12same school.

13 2 Effective Date. This act shall take effect 60 days after its passage.

METHODOLOGY:

This bill requires each school board make at least one meal available without cost to a child that qualifies based on a household income less than or equal to 300 percent of the federal poverty guidelines. The Department of Education states this bill would increase costs at the local level for providing an increased number of meals at no cost and at the state level for staffing and administration of the program as there would need to be a new process for eligibility determinations, as the current process is under USDA and are done at the local level. All costs are indeterminable at this time as it would vary across districts and the Department does not have an estimate for eligible children.
