HOUSE BILL ***625-FN-LOCAL***

AN ACT relative to the calculation of average daily membership in attendance and average daily membership in residence for school districts.

ANALYSIS

This bill modifies the calculation of ADMA and ADMR under school funding to include pupils eligible to have access to curricular courses and cocurricular programs.

Be it Enacted by the Senate and House of Representatives in General Court convened:
