# Floor Amendment to HB 489-FN-A

1	Amend the title of the bill by replacing it with the following:

6	Amend the bill by replacing all after the enacting clause with the following:

8	1 New Section; Business and Economic Affairs; Joint Promotional Program; Operational
9	Support. Amend RSA 12-O by inserting after section 17 the following new section:
10	12-O:17-a Joint Promotional Program; Operational Support Program. An operational support
11	program is hereby established as part of the joint promotional program established in RSA 12-O:17,
12	to support organizations and efforts publicizing the advantages of the state of New Hampshire for
13	tourism.
14	I. The department shall administer the operational support program. The funds
15	appropriated for this program shall be expended for grants to support the operations of
16	organizations to promote travel and tourism in the state of New Hampshire.
17	II. Funds appropriated to the operational support program shall only be made available to
18	regional associations, statewide tourist groups, chambers of commerce, county governments, or other
19	promotional organizations with the approval of the commissioner.
20	III. Grant awards shall require 50 percent matching funds from other sources, not including
21	grant awards received from the joint promotional program established in RSA 12-O:17. The
22	maximum grant amount shall be \$40,000.
23	IV. Grant applications shall be reviewed by appropriate staff, which shall recommend
24	approval or disapproval of applications to the commissioner of business and economic affairs.
25	V. Funds appropriated for the operational support program for the first fiscal year of any
26	biennium shall not lapse and shall be available for expenditure during the second fiscal year of the
27	biennium. All funds which have not been expended by the end of the second fiscal year of a
28	biennium shall lapse to the general fund.
29	VI. The commissioner shall adopt rules under RSA 541-A governing the operational support
30	program. The rules shall include:

1	(a) A description of the proposed operational support program, stating the general
2	course and method of its operations and the methods by which the public may obtain information or
3	make submissions or requests;
4	(b) The procedures and criteria used to certify groups or organizations eligible for
<b>5</b>	matching grants;
6	(c) The application process, including the information required of applicants;
7	(d) The procedures and criteria used to evaluate grant applications; and
8	(e) Procedures for the administration of grants by recipients, including reporting
9	requirements.
10	2 Appropriation; Department of Business and Economic Affairs, Division of Travel and Tourism.
11	The sum of \$750,000 for the fiscal year ending June 30, 2023 is hereby appropriated to the
12	department of business and economic affairs, division of travel and tourism for the purposes
13	specified in RSA 12-O:17-a and shall not lapse until June 30, 2025. The governor is authorized to
14	draw a warrant for said sum out of any money in the treasury not otherwise appropriated.
15	3 Effective Date.
16	I. Section 2 of this act shall take effect June 30, 2023.

17 II. The remainder of this act shall take effect July 1, 2023.
