"Distance education" and "remote instruction" mean any instructional mode that is not 1516in-person instruction including, but not limited to, correspondence, video-based, Internet-based, 17online courses, remote instruction, or any combination thereof. The terms distance education and remote instruction also include hybrid instructional models that utilize elements of distance 1819education and traditional classroom instruction in any combination. 203 Effective Date. This act shall take effect upon its passage.
