This bill prohibits a nonresident employed in New Hampshire through the federal H-2A temporary agricultural worker program from operating a motor vehicle unless they possess a license issued by another U.S. jurisdiction or meet other listed requirements.

Be it Enacted by the Senate and House of Representatives in General Court convened:

He or she holds a valid driver's license or permit to operate a motor vehicle from a jurisdiction 9 outside the United States and: 10 (a) Is at least 18 years of age; 11 (b) Is lawfully present in the United States; 12 (c) Has been present in the United States for less than one year; and 13 (d) He or she possesses an international driving permit if their license issued from a 14 jurisdiction outside the United States is not written in English. 15 III. Nonresidents who satisfy the requirements under this section shall have a maximum of 300 16 days from the date their residency was established to obtain a driver's license issued by the state of New 17 Hampshire. 18 220:2 Nonresident Who Establishes a Residency in the State. Amend RSA 263:35 to read as 19 follows: 20 263:35 Nonresident Who Establishes a Residency in the State. Notwithstanding the provisions of 21 RSA 261:44 or any other law to the contrary, any nonresident driver of a motor vehicle who holds a valid 22 driver's license in another jurisdiction, upon the establishment of a bona fide residency in this state, shall 23 have a maximum of 60 days from the date his or her residency was established to obtain a driver's license 24 issued by the state of New Hampshire; provided that H-2A temporary agricultural workers satisfying the 25 requirements under RSA 263:35-a shall have a maximum of 300 days. 26 220:3 Effective Date.
