AN ACT relative to the election of Strafford county commissioners.

ANALYSIS

This bill changes how county commissioners are elected in Strafford county and provides that all county commissioners shall be elected at large.

Be it Enacted by the Senate and House of Representatives in General Court convened:

1 1 Strafford County; Elected for 2-Year Term; County Commissioner Districts. Amend RSA
2 653:1, VI(c) to read as follows:

3 (c) Strafford county - ~~[one county commissioner by the voters in each county~~
4 ~~commissioner district]~~ **3 county commissioners by all the voters of the county;**

5 2 Strafford County; County Commissioner Districts. Amend the introductory paragraph of RSA
6 662:4 to read as follows:

7 662:4 County Commissioner Districts. ***Except for Strafford county where 3 county***
8 ***commissioners shall be elected at large,*** for the purposes of choosing county commissioners, the
9 counties shall be divided into districts as follows:

10 3 Strafford County; County Commissioner Districts. Amend RSA 662:4, IX-X to read as follows:

11 IX. ~~[Strafford: District 1, the towns of Farmington, Middleton, Milton, New Durham, wards~~
12 ~~1, 5, and 6, of the city of Rochester, and wards 1, 2, 3, 4, and 5 of the city of Somersworth; District 2,~~
13 ~~wards 1, 2, 3, and 4 of the city of Dover, and the towns of Durham, Lee, and Rollinsford; District 3,~~
14 ~~Barrington, wards 5 and 6 of the city of Dover, Madbury, wards 2, 3, and 4 of the city of Rochester,~~

16 X.] Sullivan: District 1, the town of Cornish and the city of Claremont; District 2, the towns
17 of Croydon, Grantham, Newport, Plainfield, and Springfield; District 3, the towns of Acworth,
18 Charlestown, Goshen, Langdon, Lempster, Sunapee, Unity, and Washington.

19 4 Effective Date. This act shall take effect January 1, 2025.
