15	II. Members of the committee shall receive mileage at the legislative rate when attending to
16	the duties of the committee.
17	III.(a) The committee shall examine certain laws codified under RSA Title XXXIV, Public
18	Utilities, to determine if they should be amended, recodified, or repealed. Specifically the committee
19	shall examine:
20	(1) RSA 362-E, on the telecommunications equipment assistance program.
21	(2) RSA 367, on the formation and union of railroad corporations; leases and

23	(3) RSA 368, on railroad trustees and holding companies.
24	(4) RSA 372, relative to laying out railroads.
25	(5) RSA 373, relative to crossings, stations, fences, cattle guards, bridges, and bridge
26	guards, and including optional rulemaking under RSA 21-L:12-a, VII.
27	(6) RSA 377, relative to railroad transportation of passengers, baggage, and freight.
28	(7) RSA 379, relative to joint, connecting, and terminal service, and including
29	optional rulemaking under RSA 21-L:12-a, X and XI.
30	(8) RSA 380, relative to railroads; fire damage and prevention.
31	(9) RSA 381, relative to railroad police, and including rulemaking under RSA 21

P:14, II(p) and appointment under RSA 228:62-a.

1	(10) RSA 382, relative to maintenance of parks by railroads and bus lines.
2	(b) The committee shall seek the input, advice, and expertise of any agency or
3	organization with knowledge of the subject matter, including at least the department of energy, the
4	public utilities commission, the department of transportation, and the department of safety.
5	IV. The members of the committee shall elect a chairperson from among the members. The
6	first meeting of the committee shall be called by the first-named house member. The first meeting o
7	the committee shall be held within 45 days of the effective date of this section. Three members o
8	the committee shall constitute a quorum.
9	V. The committee shall report its findings and any recommendations for proposed legislation
10	to the speaker of the house of representatives, the president of the senate, the house clerk, the
11	senate clerk, the governor, and the state library on or before November 1, 2023.
12	5 Effective Date.
13	I. Section 4 of this act shall take effect upon its passage.
14	II. The remainder of this act shall take effect July 1, 2023.
