Miscellaneous Sales is much higher than budgeted due to the sale of our property known as the Brentwood Game Farm which sold in February 2020 (G&C Item #54 approved 2/5/20) for \$536,100. Pursuant to RSA 206:34-a, the proceeds from the sale were returned to the Fish and Game Fund and dedicated to the benefit of another NHFG property known as the Emery Farm Tract.

NHFG has been awarded a competitive NOAA grant under their National Estuarine Research Reserve Procurement Acquisition and Construction (NERR PAC) in the amount of \$999,595 requiring state matching funds of \$428,399. Both the application and final grant budget document contain language specific to the sale of the Brentwood property being used as the grant matching funds.
