### CAPITAL BUDGET PROPOSALS FOR FY 2024-2026 GOVERNOR'S ADVISORY COMMITTEE June 21, 2022

New Proposed Capital Budget Projects

Thank you for this opportunity to make this presentation to you.

During the next biennium, there are several important new capital budget needs at the New Hampshire Veterans Home (NHVH). Below they are described in order of priority:

1. Building Wide Sprinkler System Upgrade – (Add from original request)

Capital Budget Request: \$297,000.00 (GF% 100%)

This project is an add-on request from our previous submission. Veterans Affairs (VA) Survey results received after Capital Budget was submitted identified Tarr South closets in need of individual sprinklers. The NHVH challenged the finding on a small room exemption and categorical "hospital" use. Challenge was denied. Upon further investigation, none or our closets comply with closet sprinkler requirements and will have to be renovated building-wide to maintain our VA Certification (we currently have provisional certification until September 2023. The NHVH will design immediately, bid over the winter, and execute construction July 2023. We request DAS prioritize this project to take place immediately upon FY 2023.

 Sitewide Drainage and Water Life Safety Improvements – <u>Capital Budget Request:</u> \$540,000 (GF% 100%)

This project will design, and correct health life safety issues related to poor drainage and overall water issues throughout the NHVH Site in Tilton. Currently, significant amounts of water seeps into the LEDU basement electrical room and is frequently mopped up by staff or await evaporation. This project will decrease the State's utility consumption.

3. Entryway Life Safety Improvements –

Capital Budget Request: \$200,000 (GF% 100%)

This project will construct four entryways at the NHVH in Tilton NH. Currently, snow falls off the existing metal roofs and risk injury to residents, staff, and visitors alike. To mitigate this, the NH Veterans home has had to block off sections of the sidewalk in winter times. This project was initially designed in 2019 (project number 80878) but cost estimates are in need of re-examination as well as a possible additional structure at the front sidewalk.

#### 4. Enhanced Security Card Reader Door Access Building Wide -

Capital Budget Request: \$780,000 (GF% 100%)

This project will complete "phase two" of the installation of Electronic Access System (Card Readers) at the NH Veterans Home in Tilton NH. Card readers were initially installed in 2018 but funding availability resulted in only completing approximately half of the required installation. This project will replace all key locks and codes with card access for doors, both internal and external to the building. This project is critical in both to keeping residents safe from external threats, but also keeping residents safely in authorized areas of the building and free from hazards.

#### 5. Tarr South Modernization - (Candidate for deferment)

Capital Budget Request: \$434,000 (GF% 100%)

This project will renovate the area of TARR South resident rooms and common areas at the NH Veterans Home in Tilton NH. Improvements will include updated electrical, plumbing, fixtures, wall/ceiling/floor finishes, and other associated improvements. The current rooms are past their useful life and in need of renovation to look less "institutional" and more "home-like" and dignified.

#### 6. Medical Lift Installation Phase 1

Capital Budget Request: \$152,000 (GF% 100%)

This project will begin to outfit the building with ceiling lift systems to accommodate our growing bariatric population at the NH Veterans Home in Tilton NH. To phase-in requirement, this installation will consist of Phase 1, 11 lifts. This project in consistent with the strategic priority to admit more in need veterans and grow the census.

### 7. Construct Warehouse & Vehicle Storage Building

Capital Budget Request: \$1,792,000 (GF% 100%)

This project will construct a Dual Use 12,000 SF Warehouse & Vehicle Storage Facility to be collocated in the vicinity of our Maintenance Building at the NH Veterans Home in Tilton NH. Our existing 3,321 SF Warehouse is undersized and in need of expansion. Programmed area is 8,000 SF for the warehouse and 4,000 SF for the Vehicle Storage Area. This project will increase the State's utility Consumption.



# About the NHVH

In 1889, to take advantage of the federal assistance, Governor David H. Goodell established a veterans' Board of Managers, made up of prominent citizens, to select a site for a Soldiers' Home for Civil War veterans unable to care for themselves by reason of wounds, old age, or other infirmities. They chose Tilton NH as their location and The New Hampshire Soldiers' Home was dedicated during ceremonies on December 3, 1890.





Today we have the statutory capacity to care for 250 residents; about half live in the Welch/Tarr Units and the other half live in our Life **Enhancement Dimentia Unit** (LEDU). Prior to the COVID-19 Pandemic, we were budgeted for nearly 400 staff. We are an intermediate, long term care facility, offering a broad range of residential, medical, and nursing care. Recently, our greatest challenge has been recruiting and retaining staff in both our clinical and support services.

The NHVH utilizes a VA Grant program enabled under 38 CFR 51:41. Veterans receive either partial or full cost of living reimbursement. To maintain this reimbursement, the NHVH undergoes annual recertification meeting standards related to Administrative, resident rights, clinical services, and Health Life Safety requirements.


## Building Wide Sprinkler System Upgrade (\$297,000)



The NHVH challenged the finding on a small room exemption and categorical "hospital" use. Challenge was denied. Upon further investigation, none or our closets comply with closet sprinkler requirements and will have to be renovated building-wide to maintain our VA Certification (we currently have provisional certification until September 2023. The NHVH will design immediately, bid over the winter, and execute construction July 2023. We request DAS prioritize this project to take place immediately upon FY 2023.

This project will install sprinkler systems in closets in all resident rooms (approx. 300 fixtures total).










Water spews out of data port conduit during rainstorm April 2022







## Entryway Life Safety Improvements (\$200,000)


Typical 650 LB Bariatric Lift. It is the Long term plan to outfit, incrementally, the entire building
