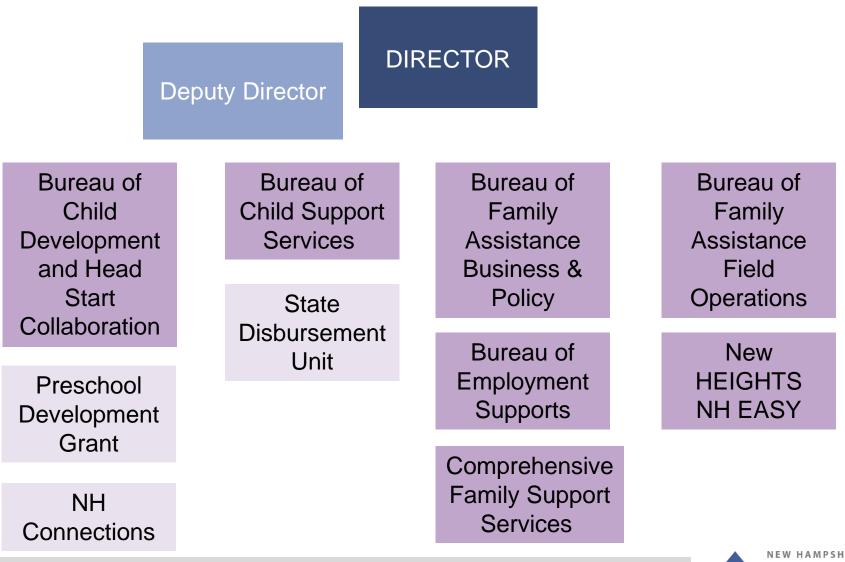

# <u>Mission</u>

To advance the health, economic and social well-being of individuals, families and communities.







#### Bureau of Child Development and Head Start Collaboration

- Administers the <u>NH Child Care Scholarship Program</u> (child care assistance)
- Strengthens the Child Care system in NH to support business and economic development
- Provides support and professional development opportunities to child care providers
- > Helps parents make informed choices to support their child's development
- Enhances the <u>quality</u> of child care to improve the child's readiness for and success in school



### **Bureau of Child Support Services**

- Services for families of children whose parents (or parent/caretaker) do not reside in the same household
- Establishes paternity and legal orders of child and medical support
- Engaging and assisting parents who are willing and able (or unable) to support their children; When necessary, enforcing the responsibility with parents who are unwilling
- Process approximately \$76 million/year in support. Payments distributed and disbursed within 48 business hours of receipt, lessening the need for government assistance benefits



#### **Bureau of Family Assistance – Director's Office**

- Administers the Supplemental Nutrition Assistance Program (SNAP), <u>Temporary Assistance to Needy Families (TANF)</u>, and <u>multiple state</u> <u>supplemental programs</u> through policy and business oversight, ensuring access to and services delivery of medical and economic assistance programs
- Collaborates across DHHS and with community programs for human services, healthcare services, navigation and homelessness to meet the needs of <u>vulnerable populations</u>
- Administers the Comprehensive Family Support Services program through <u>Family Resource Centers</u> statewide, and the Kinship Navigation program



#### **Bureau of Employment Supports** - Identified under Bureau of Family Assistance

- Administers the <u>NH Employment Program (NHEP)</u> which provides work participation services for TANF recipients to attain self-sufficiency.
- Administers <u>SNAP Employment and Training Program (E&T)</u> which helps recipients gain skills, education or work experience.
- Relationships with employers and educational/training organizations to address <u>labor market needs</u> through training and education.
- Meets family and business needs through credential attainment and workforce skill building



#### **Bureau of Family Assistance – Field Activities**

- Assists individuals and families access medical and economic assistance programs, including <u>Medicaid, TANF, SNAP and the Childcare Scholarship</u>, and <u>determines eligibility</u> for all programs
- Maintains and enhances the <u>DHHS Integrated Eligibility and Enrollment</u> <u>system</u> known as New HEIGHTS
- Maintains and enhances customer <u>self-service web portal</u> known as NH EASY
- Determines medical eligibility for disability benefits

#### House Changes

- HB1, AU 6127: Net decrease of \$336k to account for reduction training and contract needs.
- HB1, AU 7214: Addition of \$838,502 General Funds to pay for required audit of the Integrated Eligibility System.
- HB2, Section 437: Family Resource Centers: \$1 million annually General Funds).
- HB2 386: Requires DHHS adjust child care eligibility to 85% of state median income for the biennium ending June 30, 2025. Estimated \$8.6 million annually with authorization to utilize TANF funds.
- HB2 388: Requires child care service reimburse rates to match 75th percentile of market rate survey for the biennium ending June 30, 2025. Estimated \$2.9 million annually, with authorization to utilize TANF funds.
- HB2 387: Allows DHHS to utilize TANF funds to fund employment-related child care services to avoid a wait list. Included in current law (Chapter Law 91, Laws of 2021)

HB2 Budget Areas for Consideration				
Section	Title	Description		
227	Temporary Assistance For Needy Families; Maintenance of Effort	HB2 as Amended by the House appropriates \$2.5 Million General Funds each year of the biennium. The Governor's Budget included \$3 Million General for the purpose of ensuring sufficient are available for the Department to meet the required \$32 million Maintenance of Effort Requirement for Temporary Assistance for Needy Families (TANF). DHHS is requesting an additional \$500k each year to ensure sufficient funds are available to avoid any reduction or penalties to the \$38 million of federal funds annually.
