- 1. The meeting was convened as an in-person meeting at 9:00 a.m. by Sen. Reagan as Chair.

 - Item #9(b) regarding Final Proposal 2022-36 from the Real Estate Commission (License Requirements).

5. The Committee discussed the objection response to the Committee's preliminary objection to Final Proposal 2021-120 from the Department of Health and Human Services (Former Division of Mental Health and Developmental Services, In-Home Supports). Melissa Nemeth from the Department of Health and Human Services testified for the Department.

Public testimony was received from Carolyn Virtue.

Rep. Lang arrived during the public testimony.

Rep. McGuire moved that the Committee accept the response and approve Final Proposal 2021-120.

Sen. Gray seconded.

Adopted by an 8 to 2 vote, with Senator Whitley and Rep. Schuett voting "NO."

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2021-121 based on the request but expressed concern over apparent creeping costs from the federal government.

Adopted.

7. The Committee discussed Final Proposal 2021-126 from the Department of Health and Human Services (Former Division of Human Services, Home Visiting for Prenatal, Child, and Family Support Services). Nicole Burke testified for the Department.

The Department had submitted a conditional approval request in rules dated June 6, 2022.

Rep. Lang moved that the Committee conditionally approve Final Proposal 2021-126 based on the request.

Sen. Gray seconded.

Adopted.

8. The Committee discussed Final Proposal 2022-22 from the Department of Health and Human Services (Commissioner, Opioid Abatement Trust Fund and Advisory Commission). Allyson Zinno and Maria Reinemann from the Department, and James Boffetti, Deputy Attorney General, testified for the Department.

The Department had submitted a conditional approval request in rules dated June 9, 2022, and an amended conditional approval request in rules dated June 13, 2022.

Rep. Lang moved that the Committee conditionally approve Final Proposal 2022-22 based on the amended request.

10. The Committee discussed Final Proposal 2022-18 from the Insurance Department (Long-Term Care Insurance). Commissioner Chris Nicolopolus and Heather Silverstein testified for the Department.

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2022-18, on the condition that the Department replace Ins 3601.30(i) on p. 44 of the rule text with, "(i) Conflict with Other Laws. RSA 420-J:5-a, RSA 420-J:5-b, RSA 420-J:5-c, and Ins 2703 shall not be applicable for the purposes of external review requirements for long term care insurance."
