Sen. Innis seconded.

Adopted.

4. The Committee discussed postponing FP 2022-232, FP 2023-27, FP 2023-116, FP 2023-48, FP 2023-61, and FP 2023-103 to another meeting.

Rep. Schmidt moved to approve the postponements, and to request waivers for FP 2023-116, FP 2023-48, FP 2023-61, and FP 2023-103 of the Committee's deadline to act on the Final Proposals.

Rep. Haaken-Phillips seconded. Adopted.

5. The Committee discussed Final Proposal 2023-31 from the Board of Education (Procedures for Approval for Professional Educator Preparation Programs). Stephen Appleby from the Department of Education testified for the Board. The Board had submitted a Conditional Approval Request in amended rules dated 8-9-23.

Rep. Schmidt moved to conditionally approve Final Proposal 2023-31 based on the request and amending Ed 601.01(k) to read, "Clinical experience educator' means individuals from PEPPs and pre-K through 12 school-based licensed teachers, specialists, or administrators, who meet the requirements of Ed 604.03,

including educators who assess, support, evaluate, and develop a candidate's knowledge, skills, or professional disposition."

Sen. Innis seconded.

Adopted.

6. The Committee discussed Final Proposal 2023-44 from the Board of Professional Engineers (Ethical Standards and License Surrender). No one testified for the Board.

Senator Gray joined the meeting at this time. Rep. McGuire designated Sen. Gray to sit for Sen. Whitley, who was absent.

Rep. McGuire moved to postpone Final Proposal 2023-44 to another meeting, and to request a waiver of the Committee's deadline to act on the Final Proposal.

Rep. Schmidt seconded.

Adopted.

7. The Committee discussed Final Proposal 2023-105 from the Board of Professional Geologists (Reinstatement of a License Lapsed for Non-Renewal). No one testified for the Board. The Board had submitted a Conditional Approval Request in amended rules dated 8-7-23.

Sen. Chandley moved to conditionally approve Final Proposal 2023-105 based on the request and amending Geo 401.05(h)(1) to include the name of the form, "Universal Application for License Renewal", in the rule text without making any other changes to the substance of the sentence.

Sen. Ward seconded.

Adopted.

8. The Committee discussed Final Proposal 2023-136 from the Department of Environmental Services (Water Quality and Quantity Programs, Alteration of Terrain). Courtney Lockwood testified for the Department. The Department had submitted a Conditional Approval Request in amended rules dated 8-10-23.

Sen. Innis moved to conditionally approve Final Proposal 2023-136 based on the request and amending the last line of the certification on page 4 of the "Alteration of Terrain, Amendment Request Form", NHDES-W-01-001, dated August 2023, to specifically cite RSA 641:3.

Rep. Schmidt seconded.

Adopted.

9. The Committee discussed Final Proposal 2023-135 from the Department of Agriculture, Markets, and Food (Land Evaluation). No one testified for the Department.

Sen. Ward moved to preliminarily object to Final Proposal 2023-135 based on Committee Staff's written comments.

10. The Committee discussed Final Proposal 2023-142 from the Department of Business and Economic Affairs (Broadband Matching Grant Initiative (BMGI)). No one testified for the Department, although a representative was present. The Department had submitted a Conditional Approval Request in amended rules dated 8-9-23.

Sen. Innis moved to conditionally approve Final Proposal 2023-142 based on the request.

Sen. Ward seconded.

Adopted.

11. The Committee discussed Final Proposal 2023-49 from the Board of Natural Scientists (Ethical Standards) and Final Proposal 2023-50 (Ethical Standards) from the Real Estate Appraiser Board. No one testified for the Boards.

Rep. McGuire moved to postpone Final Proposal 2023-49 and Final Proposal 2023-50 to another meeting, and to request a waiver of the Committee's deadline to act on Final Proposal 2023-50.

Rep. Schmidt seconded.

- 13. The Committee discussed Emergency Rule Doc. #13689 from the Office of Professional Licensure and Certification (Changes to Respiratory Care Practitioners' Continuing Education Requirements).
