- 1. The meeting was convened at 9:02 a.m. by Rep. Hatch as Chair.

Members present at this time, aside from Rep. Hatch, were Reps. McGuire, Schmidt, Williams, Lang, and Karrick, and Sens. Reagan, Feltes, Ward, Kahn, and Watters.

Rep. Hatch designated Rep. Lang as an alternate for Rep. Hoelzel, and Sen. Watters as an alternate for Sen. Dietsch, who were absent.

2. The Committee discussed the minutes of the Committee meeting on June 21, 2019.

Sen. Feltes moved that the minutes be approved.

Sen. Reagan seconded.

Adopted.

Sen. Reagan moved that the Committee approve the Consent Agenda, except for Final Proposal 2019-61, that is, approve the Final Proposals in Item #2 except for Final Proposal 2019-61 and conditionally approve Final Proposal 2019-64 in Item #3 based on the agency's conditional approval request.

Rep. Schmidt seconded.

Adopted.

4. The Committee discussed Final Proposal 2019-61 from the Board of Registration in Optometry (Fee Schedule). Joseph Shoemaker from the Office of Professional Licensure and Certification testified for the Board.

Rep. Sytek arrived in the meeting at this time, but he was not a voting member.

Rep. Schmidt moved that the Committee postpone action on Final Proposal 2019-61 to the regular Committee meeting on August 15, 2019, and request a waiver from the Director of the Office of Legislative Services of the Committee's August 12, 2019 deadline to act on Final Proposal 2019-61.

Rep. Williams seconded.

Rep. McGuire requested that the Board also provide data on Board expenses so that they may be considered with the Final Proposal.

The motion was adopted.

5. The Committee discussed Proposed Interim Rule INT 2019-15 from the Board of Veterinary Medicine (Rules of the Board of Veterinary Medicine).

Sen. Reagan moved that the Committee approve Proposed Interim Rule INT 2019-15.

Rep. Schmidt seconded.

The Committee recessed on this Proposed Interim Rule while copies were made of relevant written testimony from Dr. Stephen Crawford, State Veterinarian.

6. The Committee discussed Final Proposal 2019-37 from the Lottery Commission (Games of Chance). Valerie King testified for the Commission.

The Commission had submitted a conditional approval request in a letter and amended rules dated July 17, 2019.

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2019-37 based on the request.

Rep. Schmidt seconded.

Adopted.

7. The Committee resumed discussion on Proposed Interim Rule INT 2019-15 from the Board of Veterinary Medicine.

The previous motion was adopted to approve Proposed Interim Rule INT 2019-15, with the understanding that the Board would provide the Committee with information on fees collected since the former rules expired April 23, 2017.

The Chair noted for the record that Rep. McGuire voted "no".

8. The Committee discussed Final Proposal 2019-83 from the Current Use Board (Organizational and Practice and Procedure Rules and Rules on Criteria for Open Space Current Use Assessment). Rick Evans represented the Board but did not speak.

Mark J. Burger and Bradford Keith indicated their opposition to the rules and a wish to speak.

Sen. Feltes moved that the Committee make a preliminary objection to Final Proposal 2019-83 on the grounds as outlined in the annotations to the Final Proposal by Committee staff, especially regarding the comment to Cub 103.04(b)(1).

Rep. Williams seconded.

Adopted.

9. The Committee discussed Proposed Interim Rule INT 2019-18 from the Department of Health and Human Services (Former Division of Public Health Services, End Stage Renal Disease Dialysis Centers). Allyson Zinno and Doreen Shockley testified for the Department.

Sen. Kahn moved that the Committee approve Proposed Interim Rule INT 2019-18.

Rep. Lang seconded.

Adopted.

10. The Committee discussed Proposed Interim Rule INT 2019-19 from the Department of Health and Human Services (Former Division of Human Services, Developing Potential Sources of Income). Allyson Zinno and Brian Clark testified for the Department.

Sen. Reagan moved that the Committee approve Proposed Interim Rule INT 2019-19.

Rep. Schmidt seconded.

Adopted.

11. The Committee discussed Proposed Interim Rule INT 2019-20 from the Department of Health and Human Services (Division of Elderly and Adult Services, Choices for Independence Program). Kim Reeve testified for the Department.

Sen. Reagan moved that the Committee approve Proposed Interim Rule INT 2019-20.

Rep. Schmidt seconded.

Adopted.

12. The Committee discussed Proposed Expedited Revision to Form EXRF 2019-1 from the Department of Health and Human Services (Former Division of Human Services, Granite Advantage Health Care Program Forms: Monthly Reporting, Reporting Education Participations, Exemption Request, and Good Cause Request). Kim Reeve testified for the Department.

Rep. Lang moved that the Committee approved Proposed Expedited Revision to Form EXRF 2019-1.

Rep. Schmidt seconded.

Adopted.

**13. The Committee discussed Final Proposal 2019-57 from the Board of Education (Minimum Standards for Computer Science and Kindergarten). Commissioner Frank Edelblut, Amanda Phelps, and Richard Sala from the Department of Education testified for the Board.

Board Chairman Drew Cline was also present but did not speak.

The Department of Education had submitted a conditional approval request in a letter dated July 17, 2019 and attached rules dated July 18, 2019.

Sen. Watters moved that the Committee conditionally approve Final Proposal 2019-57 based on the request.

Rep. Schmidt seconded.

Adopted.

14. The Committee discussed Final Proposal 2019-5 from the Board of Education (Learn Everywhere Program for High School Graduation Credit). Commissioner Frank Edelblut, Amanda Phelps, and Richard Sala from the Department of Education testified for the Board. Chairman Drew Cline also represented the Board.

Sen. Feltes recused himself from discussing or voting on Final Proposal 2019-5 due to a potential conflict of interest under Senate Rule 65. Rep. Hatch therefore designated Rep. Karrick as an alternate for Sen. Feltes.

Sen. Reagan read into the record the written testimony of Rep. Barbara Shaw in support of the rules.

Sen. Kahn moved that the Committee make a preliminary objection to Final Proposal 2019-5 on the following grounds:

- 1. Rule Ed 1407.02(a) is **contrary to legislative intent to the extent that** the rule violates the specific statute RSA 193-E:2-a, V(a), and the rule violates the more general statutory purpose clause RSA 193-E:1, II, because the statutory intent of both was to create a bifurcated system where the Board of Education mandates the minimum standards for graduation, and the local school districts maintain the specific curriculum which dictates the credit needed for those minimum standards for graduation. The proposed rule, in requiring a school district to accept completion certificates for up to 1/3 of graduation credits from a Learn Everywhere Program, violates the statutes because it requires the school district to grant credit for curriculum it has not approved;
- 2. Rule Ed 1400 is **contrary to legislative intent to the extent that** the rule violates the overall purpose of the statute RSA 193-E because the statute delegates to school districts responsibility for the specific curriculum for which credit is granted;
- 3. Rule Ed 1407.02(a) is **beyond the Board's authority** because RSA 193-E:2-a, V(b) does not give the Board the authority to require a school district to grant credit for programs or courses when the school district did not itself approve the curriculum;

- 4. Rule Ed 1407.02(a) is **contrary to the public interest** because it conflicts with the existing rule Ed 306.27. The conflict creates a situation where the rules cannot be uniformly applied because a school district must at the same time approve a curriculum before granting credit and yet grant credit for that same curriculum without approving it first;
- 5. Rule Ed 1407.02(a) is **contrary to the public interest** because it conflicts with the existing rule Ed 306.21(h) regarding the requirement that staff assigned to alternative programs meet the same certification requirements as staff assigned to standard schools. The conflict creates a situation where school districts would be accepting credit from a program without knowledge of the teacher's credentials;
- 6. Rule Ed 1407.02(b) is **contrary to the public interest** because it is unclear and thus cannot be uniformly applied. The rule is unclear because it does not account for how a school district is to apply credit that it is required to grant if a student has already fulfilled that credit area; and
- 7. Rule Ed 1409.01(a) is **contrary to the public interest** because it conflicts with Ed 403.01(a)(2)o. Ed 1409.01(a) allows for complaints to be submitted to the Department of Education but excludes complaints that might be made regarding student safety from bullying, harassment, or abuse, because the program is not required to have the grievance policy required by Ed 403.01(a)(2)o.

Sen. Watters seconded.

Rep. McGuire moved that the Committee amend the motion, based on the testimony of Gerald Zelin, to add an eighth ground as follows:

8. Rule Ed 1401.02(c) is **beyond the authority of the Department** because it conflicts with RSA 193-E:2-a, V(b) since it expands the Learn Everywhere Program to include programs that would not grant credit if the programs would help a student make progress toward one or more of the student's annual goals set forth in his or her IEP.

Sen. Kahn seconded.

The amendment was adopted.
