1. The meeting was convened at 9:04 a.m. by Rep. Patten as Chair.

Members present at this time, aside from Rep. Patten, were Reps. Pilotte, Schmidt, Kidder, Bowers, and Winter, and Sens. White and Carson.

Sen. Merrill and Rep. McGuire arrived shortly after the meeting convened, and Sen. White left.

Rep. Patten appointed Sen. Carson, Rep. Winter, Rep. Bowers, and Rep. Kidder as alternates, respectively, for Sen. White, Rep. Manuse, Sen. Lambert, and Sen. Kelley, who were absent.

2. The Committee discussed the response by the Department of Labor to the Committee's preliminary objection to Final Proposal 2011-161 (Employee Leasing Companies) and the Department's request to the Acting Director of the Office of Legislative Services for a waiver of the deadline to submit the response.

Martin Jenkins, Department Legal Counsel, testified for the Department.

Rep. McGuire moved that the Committee recommend that a waiver be granted.

Sen. Merrill seconded.

Adopted.

Rep. Schmidt moved that the Committee object to Proposed Interim Rule INT 2012-7 on the grounds that the rule was contrary to legislative intent due to conflict with SB 311 (2012) and SB 157 (2011) and contrary to public interest by being unclear relative to fees for testing, certification, and sealing.

Sen. Carson seconded.

Adopted.

It was the consensus of the Committee that the response to the objection be placed on the Committee's agenda for its continued meeting on October 4, 2012 if the response is received prior to the meeting.

Rep. Pilotte moved that the minutes be approved.

8. The Committee discussed the following Final Proposal for which the agency had submitted a conditional approval request:

9. The Committee discussed Final Proposal 2012-76 from the Board of Registration in Optometry (Rules Regarding Pharmaceutical Agents, Continuing Education Form, Misconduct Investigations and Disciplinary Sanctions for Optometrists).

Rep. McGuire moved that the Committee conditionally approve Final Proposal 2012-76 on the condition that the words "on an ex parte basis" in Opt 501.03(d) be replaced by the words "by a member of the board who shall recuse himself from the adjudicatory hearing."

The Department had submitted a conditional approval request in a letter and amended rule dated September 17, 2012 and an amended conditional approval request in a further amended rule dated September 17, 2012.

Daniel Phelps, representing N.H. Legal Assistance, also testified.

Rep. Pilotte moved that the Committee accept the amended conditional approval request and conditionally approve Final Proposal 2011-160 based on the request.

The Department had submitted a conditional approval request in an amended rule received September 19, 2012.

Rep. Schmidt moved that the Committee accept the conditional approval request with the further amendment to Tra 1003.02(d) by replacing "48 hours" with "2 business days" and an amendment to Tra 1003.04(e) by changing the capital "D" in "Department" to a lower case "d", with no further changes in capitalization, and conditionally approve Final Proposal 2012-21 based on the request as amended.

Rep. Pilotte seconded.

Adopted.

14. The Committee discussed Final Proposal 2009-193 from the Department of Cultural Resources (Division of Historical Resources, Organizational Rules). Elizabeth Muzzey, Division Director, testified for the Department.

The Department submitted a conditional approval request in an amended rule in the meeting.

Rep. Pilotte moved that the Committee accept the conditional approval request with amendment to change "RSA 229-C:9" in Cul-H 103.01 to "RSA 227-C:9".

Sen. Merrill seconded.

Adopted.

Sen. Merrill and Sen. Carson left the meeting at this time.

Rep. McGuire moved that the Committee make a preliminary objection to Final Proposal 2012-106 based on Committee staff comments on pages 4 and 5 of the Final Proposal, with the understanding that the Committee would not vote to sponsor a joint resolution to the Objection Response.
