6. (a) Summary of what the rule says and of any proposed amendments:

The rule applies to all newly hired police, corrections, and probation/parole officers. This rule specifies the time limits for completion of the training programs, good cause for extensions of time to complete programs, and the limitations imposed upon uncertified officers that are working.

The proposed amendments are being made to require that uncertified officers may work only in the direct presence of a certified officer until the officer completes the required basic training program.

The proposed rules require that if a newly appointed uncertified police, corrections, or probation/parole officer works before successfully completing the basic training requirements under Pol 302.01(a), they only do so in the direct presence of a certified police, corrections, or probation/parole officer, respectively. To the extent state, county, or local law enforcement agencies choose to have uncertified officers work, they may incur additional costs relative to supervision.

- B. To State citizens and political subdivisions: See #3 above.
- C. To independently owned businesses: None.

# 5. Short Title: Definitions, Legal Address, Application, Renewal of Registration, and Reinstatement of Registration

6. (a) Summary of what the rule says and of any proposed amendments:

This proposal readopts with amendment the following sections, which were originally effective 5-5-16:

- Mtec 301.01, relative to definitions, in order to amend the definition of "medical technician" in paragraph (g), and therefore to codify in rule the declaratory ruling filed by the Board on 4-3-18 that "medical technician" does not include staff who perform nonmedical functions or assist in non-medical forms of personal care;
- (2) Mtec 302.06, relative to legal address, to simplify and clarify the requirements for providing addresses. The proposed amendment makes clear that all applicants must provide both a physical address and, if applicable, a mailing address;
- (3) Mtec 304.01, relative to the application form for initial licensure, to make the following changes:
  - a. In Mtec 304.01(b)(1), the proposal clarifies that applicants must provide their legal name, as opposed to any name;
  - b. In Mtec 304.01(b)(8), the proposal makes clear that the form itself is only asking for the answers to the "yes/no" questions; and
  - c. In Mtec 304.01(c), an explanation to any "yes" question in Mtec 304.01(b)(8) must be included with the form (as opposed to on the form, as currently written);
- (4) Mtec 401.02, relative to the form for renewals of registration, to make the following changes:
  - a. In Mtec 401.02(b)(1), the proposal clarifies that applicants must provide their legal name, as opposed to any name;
  - b. In Mtec 401.02(b)(8), the proposal makes clear that the renewal form itself is only asking for the answers to the "yes/no" questions relative to circumstances that either occurred in the last 2 years or have not been previously disclosed to the Board;
  - c. In Mtec 401.02(c)(2), the proposal states that an explanation to any "yes" question in Mtec 401.02(b)(8) must be included with the form (as opposed to on the form, as currently written); and

- (5) Mtec 401.04, relative to the form for reinstatement of registrations, to make the following changes:
  - a. In Mtec 401.04(a) and (c), the 1-year limitation on reinstatement is removed. Under the proposed rules, any licensee who allows his or her license to lapse will be required to reinstate regardless of how long the license has been lapsed;
  - b. In Mtec 401.04(a)(1), the proposal clarifies that applicants must provide their legal name, as opposed to any name;
  - c. In Mtec 401.04(a)(8), the proposal makes clear that the reinstatement form itself is only asking for the answers to the "yes/no" questions that either occurred since the registration lapsed or which have not been previously disclosed to the board; and
  - d. In Mtec 401.04(b)(2), the proposal states that an explanation to any "yes" question in Mtec 401.04(a)(8) must be included with the form (as opposed to on the form, as currently written).
