5. Short Title: **Organizational Rules and Rules of Procedure of the Board of Veterinary Medicine**

6. (a) Summary of what the rule says and of any proposed amendments:

This proposal implements the organizational rules and procedures of the Board of Veterinary Medicine, pursuant to RSA 332-B, in Vet 100 and Vet 200, respectively. The purpose of the rules of the Board is to promote public health, safety, and welfare by safeguarding the people of New Hampshire against incompetent, unscrupulous, and unauthorized persons and from unprofessional or illegal practices.

This proposal re-adopts with amendments Vet 100, Organizational Rules; Vet 201, Filing of Complaints; and Vet 202, Disciplinary Hearings. The amendments expand the list of definitions and expand the information required in both a response to a statement of allegations and an investigator’s report to the Board.

This proposal re-adopts Vet 203, Vet 204, and Vet 205 relative to petitions for rulemaking, the public comment hearing process, and declaratory rulings.

The proposal also re-adopts Vet 206, Explanation of Adopted Rules, which is currently an interim rule which is scheduled to expire 1-28-20.

6. (b) Brief description of the groups affected:

The regulation of veterinary medicine affects those practicing veterinary medicine, those employed by veterinarians, and those animal owners seeking the services of veterinarians.

These rules support RSA 332-B, the purpose of which is to promote public health, safety, and welfare by safeguarding the people of New Hampshire against incompetent, unscrupulous, and unauthorized persons and from unprofessional or illegal practices.

6. (a) Summary of what the rule says and of any proposed amendments:

This proposal implements the standards and procedures of the Board of Veterinary Medicine, pursuant to RSA 332-B, in Vet 300 through Vet 1000, the purpose of which is to promote public health, safety, and welfare by safeguarding the people of New Hampshire against incompetent, unscrupulous, and unauthorized persons and from unprofessional or illegal practices.

Most of the existing rules in Vet 300-Vet 700 are interim rules which are scheduled to expire 1-28-20.

The proposal readopts with amendments Vet 301 through 303 regarding Application Procedures, Qualifications, and Examination.

The proposal repeals the existing Vet 304, Reciprocity.

The proposal readopts with amendments Vet 305, Temporary Permit, and renumbers it as Vet 304. The proposal also readopts with amendments Vet 306, Fees, and renumbers it as Vet 305.

The proposal readopts with amendments Vet 400, Continued Status.

The proposal readopts with amendments Vet 501.01 and Vet 501.02 regarding the Principles of Veterinary Medical Ethics.

The proposal readopts with amendments Vet 502.01 and renames the section as Emergency Coverage and After Hours Care.

The proposal readopts with amendments Vet 601, Acupuncture. The proposal readopts Vet 602, Embryo Transfers.

The proposal readopts with amendments Vet 700, Veterinary Medical Records.

Proposed changes include requiring the use of the applicant's legal name for licensing; reconsideration of what criminal convictions can affect licensing; clarification of the temporary permitting process; increased licensing fees and fees for certain records while eliminating late fees; submission of public discipline to the American Association of State Veterinary Boards; clarified requirements for reporting of continuing education; clarified provisions for emergency and after hours care; and clarification of expected record-keeping standards.

The proposal also adopts new rules Vet 306, Reinstatement of an Expired License; Vet 501.03, Veterinary Specialists; Vet 502.02, After Hours Care; Vet 503, Euthanasia; Vet 603, Telemedicine; Vet 800, Veterinary Nurses, Veterinary Technicians, and Veterinary Assistants; Vet 900, Dental Care; and Vet 1000, Opioid Management.

Proposed additions include clarification relative to addressing expired licenses; requiring the use of the applicant's legal name for licensing; restrictions on the use of specialty designations; reference to standards for euthanasia; clarification of allowable uses of veterinary nurses, technicians, assistants, and students; restrictions on veterinary dental care; and required acts related to opioid management.

The Board assumes in the future, the additional revenue will pay for the creation of a full-time position to support board activities that are not currently supported by the operating budget.

There is no cost or benefit associated with new sections Vet 306, Vet 501.03, Vet 502.02, Vet 503, Vet 603, and Vet 900. The Board assumes the proposed Vet 800 rules, which distinguish between veterinary assistants and veterinary technicians, will result in savings to practices that employ technicians but don't utilize them to the full extent of their training. The Vet 800 rules could result in additional costs to certain veterinary practices that could no longer use un-credentialed staff for certain tasks. The Board indicates the requirements in Vet 1000 regarding opioid management will result in additional costs to veterinary practices, however such costs are attributable to RSA 318-B and RSA 332-B:7-a, XV and not the proposed rules.

5. Short Title: **Physician Services**

6. (a) Summary of what the rule says and of any proposed amendments:
He-W 531 prescribes the requirements for and describes the services available under the NH medicaid fee for service (FFS) program for physician services. The rule includes recipient eligibility requirements, provider participation requirements, service limits, and covered and non-covered services. This rule is effectively being readopted with amendment to avoid expiration for some provisions in He-W 531.01, and for He-W 531.02, 531.03, 531.04, and 531.09, which are otherwise scheduled to expire 11-14-19 but are subject to extension pursuant to RSA 541-A:14-a. The other portions of the rule are being submitted with the proposal so that the entire rule will have a single expiration date.

The proposed changes from the existing He-W 531 rule are as follows:

- Updating the rule for better clarity, program integrity, programmatic changes, and to be consistent with other Departmental rules;
- Updating the rule to clarify that the Department will be using the Interqual Connect Clinical Guidelines for services requiring prior authorization rather than the Milliman Care Guidelines because the Department no longer has access to those proprietary guidelines. Additionally, this change will provide consistency with the coverage criteria being used by Medicaid managed care organizations (MCOs) as they also use Interqual’s criteria; and
- The utilization review and control section, He-W 531.08, has been updated to be consistent with recently adopted rules in terms of updated citations and clarifying that failure to comply will result in recoupments of Medicaid payments by the Department.

6. (b) Brief description of the groups affected:
The rule impacts all Medicaid recipients and enrolled physicians.

1. **Comparison of the costs of the proposed rule(s) to the existing rule(s):**

When compared to the existing rules, the proposed rules will have an indeterminable impact on costs to state citizens and independently-owned businesses.

2. **Cite the Federal mandate. Identify the impact on state funds:**

No federal mandate, no impact on state funds.

3. **Cost and benefits of the proposed rule(s):**

The proposed rule clarifies that the Department of Health and Human Services will use Interqual Connect clinical guidelines for services requiring prior authorization, as opposed to the Milliman Care guidelines previously in use. The Department expects this change to have a minimal fiscal impact, as the managed care organizations (MCO) already utilize Interqual guidelines, and there are relatively few individuals who are served by the fee-for-service (FFS) program and would therefore be subject to the change. The Department notes that the FFS program serves approximately 1,000 individuals at any given time, and since the transition to managed care in 2013, FFS Medicaid has received only one prior authorization request under the rule. For this reason, although the new standard could theoretically result in coverage denials for FFS participants to the extent that there are differences between the Milliman and Interqual standards, the Department expects such instances to be rare.

- A. **To State general or State special funds:**

None.

- B. **To State citizens and political subdivisions:**

As noted in response to (3) above, FFS participants could potentially experience coverage denials under the proposed rule, but the Department expects such instances to be rare and have minimal impact.

C. To independently owned businesses:

The proposed rule states that the Department is authorized to recover federal or state Medicaid payments made pursuant to 42 CFR 455, 42 CFR 447, and 42 CFR 456. This provision will only impact providers to the extent that they are not aware of the requirements or are in noncompliance with them. In addition, the proposed rule inserts a citation for 42 CFR 1001, which describes the federal exclusions from participation in the Medicaid program. This provision is unlikely to impact providers, as it is already included in the agreement between providers and the Department.

11. Statement Relative to Part I, Article 28-a of the N.H. Constitution:

The proposal does not mandate any fees, duties, or expenditures on the political subdivisions of the state, and therefore does not violate Part I, Article 28-a of the N.H. Constitution.

5. Short Title: **Substance Abuse Reduction Initiative**

6. (a) Summary of what the rule says and of any proposed amendments:

This proposal is a readoption without change of Chapter Saf-C 2900 on the law enforcement substance abuse reduction initiative, which is currently an emergency rule that is scheduled to expire on 3-21-20. The FY20/21 budget provided funding for local law enforcement to engage in additional drug enforcement efforts. The vehicle used for this was a grant program that previously targeted opioid enforcement. Because of changes in the 2019 legislative session to the language authorizing this program in Chapter 346:316 of the Laws of 2019, the Department engaged in emergency rule making to ensure that the local governments had sufficient time to mount an effort during this fiscal year. This proposal is the followup regular rule making proposal of the same rule as the previously submitted emergency rule which became effective 10-3-19.

He-C 6910 establishes the criteria for a 12-month employment-related child care scholarship which enables families to prepare for, secure, or maintain employment, and to support healthy child development for those families who meet and continue to meet the program requirements of He-C 6910. He-C 6910 also establishes the payment amounts for an employment related child care scholarship.

In accordance with 65 E(c)(2)(M); 98.16(X) the Department of Health and Human Services (Department) is required to develop and implement strategies to increase the supply of and to improve the quality of child care services for children in underserved areas: infants and toddlers; children with disabilities; and children who receive care during non-traditional hours.

To attract new child care providers and with recruiting existing child care providers to serve more children with special needs, the Department proposes to amend He-C 6910.17 on the child care scholarship standard rate methodology as an interim rule pursuant to RSA 541-A:19, I(c) to conform with a federal requirement by amending paragraphs (b) and (g) respectively, on the weekly standard rates for licensed child care centers and family child care homes and on supplemental payments. The proposal increases the supplemental payment rate for a child experiencing significant special needs from \$50 to \$100 per week for a full time service level, from \$30 to \$75 per week for a half time service level, and from \$15 to \$50 per week for a part time service level.

In accordance with 98.16(a) the Department must certify that NH child care scholarship payment rates are sufficient to ensure equal access for families utilizing child care services comparable to those provided by families not receiving assistance. Per the preamble 81 FR 67512, the payment rates must be established based on the most recent Market Rate Survey completed by the Department.

The Department establishes a maximum weekly standard rate to be paid to enrolled child care providers. The Department conducts a federally mandated survey every 2 years, known as the Market Rate Survey (MRS), of rates charged by licensed child care centers and licensed child care homes in New Hampshire. The Department's maximum payment rates for child care services are based on the rates from this survey. This survey was conducted in March 2018. The Department proposes rates for licensed child care centers and licensed child care homes from the 50th percentile to the 55th percentile of the most recent MRS age group. The payment rates for license-exempt family child care providers are set at 70% of the licensed family child care home standard rate for each age group. The payment rates for license-exempt centers are set at 50% of the licensed child care center standard rate. The Department proposes rates for infant and toddler age groups from the 50th percentile to the 60th percentile of the most recent MRS.
