Seacoast Commission on Long-Term Goals and Requirements for Drinking Water November 1, 2021

I. Commission Charge:

Pursuant to RSA 485-F:6, the Commission shall:

Continue the work of the RSA 485-F:5 seacoast Commission on long-term goals and requirements for drinking water which was repealed on November 1, 2018

Utilize and expand upon existing studies to plan for seasonal or drought supply issues

Prepare and discuss mutual aid between seacoast towns for firefighting

Prepare and discuss mutual aid agreements for emergency or replacement drinking water supply where contaminated

Encourage coordination between towns and cities

Establish working subgroups as needed

Monitor and review the work of state agencies regarding possible new emerging contaminant threats

III. Introduction:

The Long-Term Seacoast Commission on Drinking Water continued meeting virtually due to COVID-19 restrictions from January 2021 through June of 2021 and did

not meet in July and August. In September 2021 the commission resumed in person meetings at the New Hampshire Department of Environmental Services (NHDES) office at the Pease Tradeport in Newington. Efforts to identify commission members from municipalities currently not represented are ongoing.

IV. Progress to Date:

Beginning with the January meeting and continuing throughout the year, Brandon Kernen of the NHDES presented an update on drought conditions throughout the state and specifically in the seacoast region. He also provided regular updates about the Emergency Drought Assistance program which was established to assist low-income households that experienced problems with residential wells because of the drought.

Also at the January meeting, Chair Grote raised the issue of the need for an inventory of water resources by community to serve as part of the baseline for the commission's work going forward. The inventory included a presentation of water resources by each municipality represented on the commission. NHDES began each presentation with an overview of the water sources, protection areas, distribution infrastructure, and any unique challenges to the water system for that city or town. Mr. Roache of the Rockingham Planning Commission and Ms. Czysz of the Strafford Regional Planning Commission also provided summary information for their counties. Once complete, the inventory of water assets throughout the region can be used to support efforts that could improve efficiency and reliability in water distribution and ensure water quality and availability. The review of water systems serves as a baseline overview of resources and challenges throughout the seacoast region. Those challenges include water usage and conservation efforts, and threats to water quality from both natural sources such as arsenic, radon, and manganese as well as from man-made sources such as PFAS chemicals. The reviews included efforts to manage those issues, and information about water source protection initiatives, ongoing cooperation between municipalities, and best practices for ensuring water quality and quantity.

The inventory of water resources also included information on the number of users that get their water from a public source and those that rely on private wells. The information is summarized below*:

In addition to the presentations on municipal water systems, Representative David Meuse from Portsmouth provided periodic updates on the status of legislation related to drinking water.

At the September meeting, the commission voted in favor of sending a letter to the Drinking Water and Groundwater Advisory Commission requesting up \$290,000 to

support a project proposed by NHDES to begin addressing the health risks posed by arsenic and other common contaminants in water from private wells. NHDES will conduct the Seacoast Private Well Initiative that that includes community outreach, testing, information on treatment, and free filter pitchers for qualified families and individuals whose well water has unsafe levels of contaminants. The project will be conducted in the seacoast region with a view to demonstrating practices that can be replicated in other regions of the state. The letter was sent on September 24, 2021.
